Tarmac quality and pavement quality is poor and has not been helped by construction work to our school and adjacent school

#### Inadequate

Lines are not sufficiently extensive, are only outside school gate and are ignored by parents.

Signage is hard to see due to bend in road and is not placed where approaching motorists would be aware of a school even though there are bends approaching school from both ways.

Please record any other obstacles or road layout issues within 500 metres of the school entrance which could be deemed as preventing young people or making it more difficult for them to use sustainable transport on the journey to and from school.

Road is narrow making it hard for cars to park at school start/finish times, encouraging parking on pavements. There are blind bends which cars come round fast which endangers lives.

As a residential road, there are lots of drives - parents frequently park over these causing frequent complaints from residents. Knottsall lane is extremely narrow and a steep gradient. The car park in Barnford Park is closed due to the threat of travellers accessing it.

Many parents are bringing their children on the way to work so come by car.

The path cutting through from Bristnall hall Road to Moat Road is still closed meaning parents use cars rather than walk.






